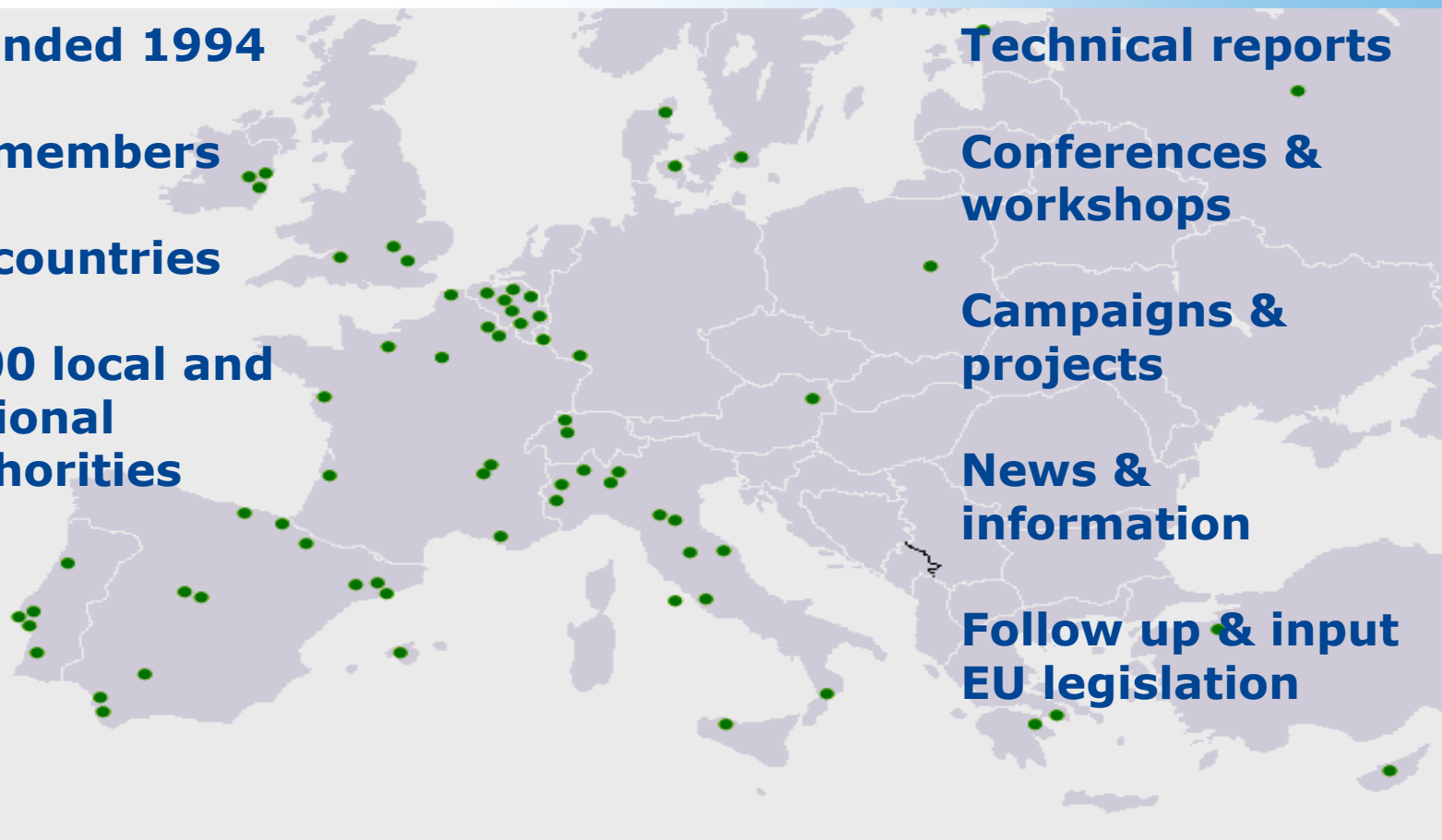

What is EPR?

EPR as an environmental policy approach in which a producer's responsibility for a product is extended to the post-consumer stage of a product's life cycle (OECD, 2010)

Objectives:

- Integration of **environmental** costs
- Improved waste management
- Reduction of **disposal of waste**
- Reduction of the **burden on municipalities**
- Design of environmentally sound products

EU waste policy and EPR



Waste Framework Directive 2008/98

Art. 8

1. In order to strengthen the **re-use and the prevention, recycling and other recovery of waste**, Member States may take legislative or non-legislative measures to ensure that any natural or legal person who professionally develops, manufactures, processes, treats, sells or imports products (producer of the product) has extended producer responsibility.

Art. 14

1. In accordance with the polluter-pays principle, the **costs of waste management** shall be borne by the original waste producer or by the current or previous waste holders..

Resource Efficiency Roadmap (20/09/2011)

MS ... assess **measures to extend producer responsibility to the full life-cycle of the products** they make (including via new business models, through guidance on take-back and recycling schemes and support for repair services)...

EC .. assess the introduction of minimum recycled material rates, durability and re-usability criteria and **extensions of producer responsibility for key products (in 2012)**.

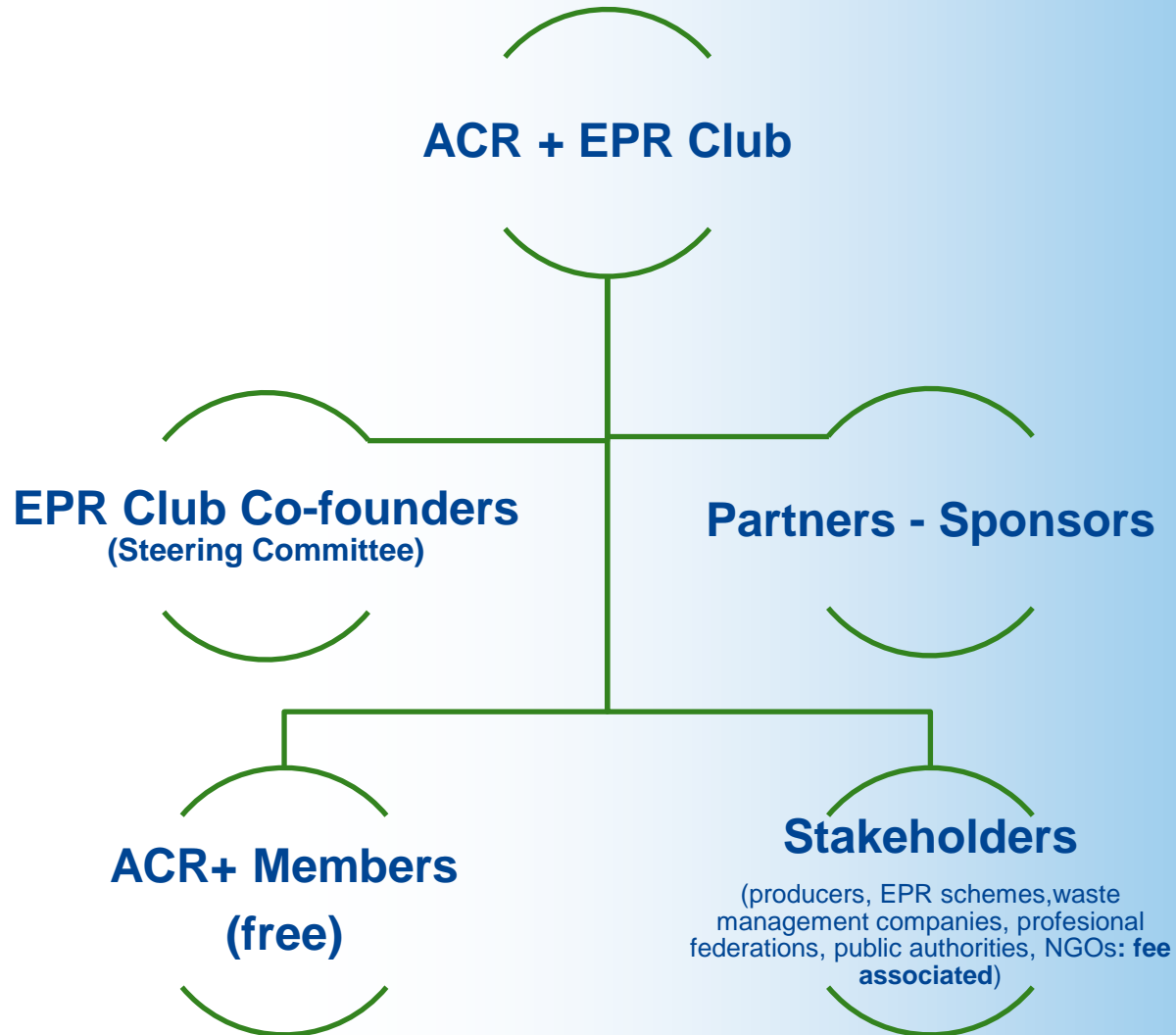
